PROCESS

The Hungarian Residency by Investment Program requires that you follow the steps as outlined:

1. PRWALE shall pre-screen your passport copy for government pre-approval to ensure fast processing. A down payment of professional fees will be required to start your application.
2. PRWALE will assist and advise you on a suitable investment option. Each option will be evaluated to determine the best fit for you.
3. PRWALE will assist you in gathering, certifying, and legalizing all required documents for visa submission.
4. After submission, the guest investor visa is typically issued within approximately 6 weeks.
5. Upon entering Hungary with your guest investor visa, you will have 93 days to submit your residency application. The investment must be completed before submission.

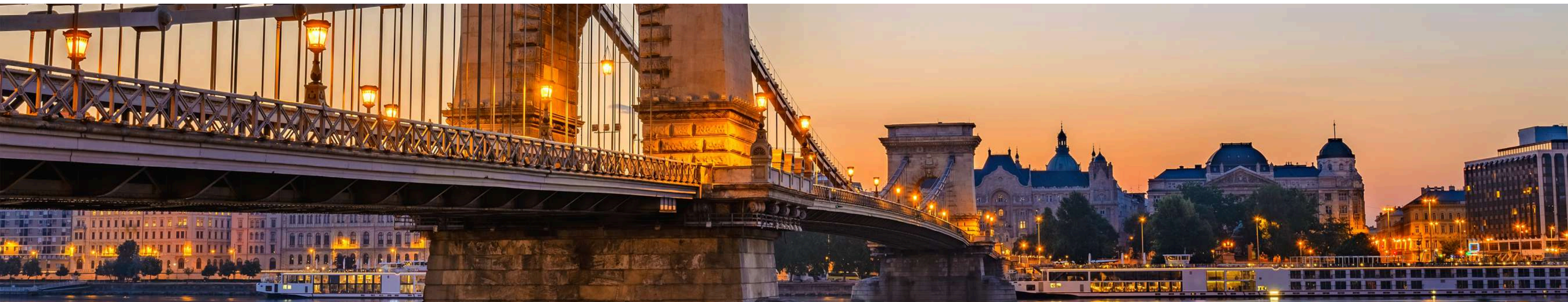

- **Hungarian Guest Investor Program**
- **Validity: 10-year residence permit + renewable 10 years**
- **Processing Time: Approx. 4–6 months**
- **Family: Spouse + children + dependent parents allowed**
- **No mandatory stay requirement to maintain residency**
- **This program allows non-EU investors (including Indians) to live in Hungary and travel within the Schengen Area**
